**CERTIFICATE OF CITIZENSHIP OF BANGLADESH UNDER CLAUSE (2) OF  
ARTICLE 2B OF THE BANGLADESH CITIZENSHIP (TEMPORARY PROVISIONS)  
ORDER, 1972 (P.O.No. 149 OF 1972).**

WHEREAS..... **SYED MUHAMMAD ABUL MANSOOR**..... whose particulars are set out below, has applied for granting citizenship, and has satisfied the Government for the grant of a certificate of citizenship;


Now, THEREFORE, in exercise of the powers conferred by clause (2) of article 2B of the Bangladesh Citizenship (Temporary Provisions) Order, 1972 (P.O.No. 149 of 1972) and the rules made thereunder, the Government hereby grant to the said..... **SYED MUHAMMAD ABUL MANSOOR**..... citizenship of Bangladesh and declare that subject to the provisions of the said Order, he/she shall be deemed to be citizen of Bangladesh and shall be entitled to all the rights, privileges and capacities to which a citizen of Bangladesh is entitled and shall also be subject to all the obligations, duties and liabilities of a citizen of Bangladesh under any or all the laws of Bangladesh provided that the granting of citizenship will not disturb his/her citizenship of the country to which he/she now belongs;

This certificate will not ipso facto entitle the grantee to claim any property declared by the Government as vested property or abandoned property.

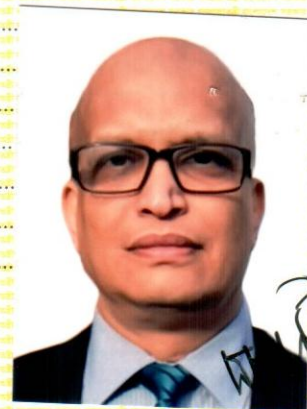
