(Approval for Beyond/Ex – Bangladesh Leave)

According to the Memo No - 58.04.0000.002.04.002.17.628, dated 19.04.1424 Bangla /03.08.2017 English – from the Directorate of Bangladesh Prisons, **(Mr. Md Iqbal Hasan), Additional Inspector General of the Directorate of Bangladesh Prisons, Dhaka, Bangladesh** is hereby granted with a Beyond/Ex – Bangladesh leave of **10 (ten) consecutive days starting from 02 October 2017 to 11 October 2017 (or for consecutive 10 (ten) days starting from a suitable date, subject to the consent of the Inspector General of Bangladesh Prisons** in order to visit France and England under the following **strict** terms and conditions :-

- There will be no financial involvement of the Government of the People's Republic of Bangladesh regarding the expenditures occurring from the leave;
- Official salaries & allowances during the leave will be made in Bangladesh currencies;
- After enjoying the leave, the officer shall join the office duly;
- Travel time from/to Bangladesh will not be counted within the duration of leave; and
- Rule no. 34 of Bangladesh Service Rules (BSR) Part - 1 (Termination of service of the Republic with the consecutive absence of 5 years from the office, excluding the persons deployed in the foreign services) shall be applicable in this circumstance.


